UCO Bank invites applications from eligible professionals for empanelment and engagement as Independent External Experts (IEE) for participation in the Committees constituted under the "Framework for Revival and Rehabilitation of Micro, Small and Medium Enterprises (MSMEs)".

Eligibility Criteria

Applicants should:

- Possess a minimum of three years' experience in credit-related matters pertaining to the MSME sector.
- Have adequate knowledge of financial analysis, project appraisal, techno-economic viability assessment, rehabilitation and restructuring of MSME units.
- Be of sound professional standing and integrity.
- Be not more than 65 years of age as on the date of application.

Roles and Responsibilities

The Independent External Expert shall:

- Participate in meetings of the Committee for Stressed MSMEs.
- Examine stressed MSME accounts and provide expert inputs for formulation of Corrective Action Plans (CAP).
- Assist in evaluating the Techno-Economic Viability (TEV), feasibility and bankability of projects.
- Suggest appropriate measures for revival, rehabilitation, restructuring or recovery of stressed MSME accounts.
- Maintain strict confidentiality of all information and execute a declaration of secrecy as prescribed by the Bank.

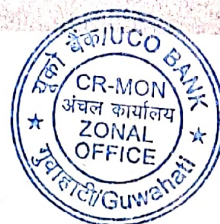
Remuneration

Fixed remuneration of ₹3,500/- per day (inclusive of conveyance and incidental expenses) irrespective of the number of accounts/meetings handled on a particular day. In Metro and Major 'A' Class Cities, an additional amount up to ₹500/- per day may be sanctioned as per Bank guidelines.

Period of Engagement

- The engagement shall be on a contract basis for one year.
- Renewal may be considered based on satisfactory performance and requirement of the Bank.

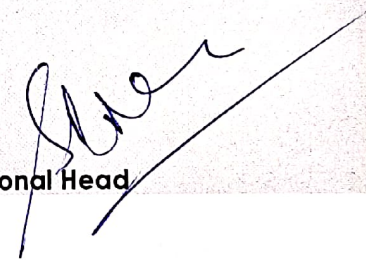
