1) UCO Bank intends to sell Seven Maruti Swift Dzires, three Maruti Zen Estilo, four Honda City car's by open tender on as is where is basis as per its market value. The details of all vehicles such as version of car, Colour , Km covered, Date of Purchase, Registration No, Registration & Road Tax valid up to, Insurance Valid up to, etc. are given in Annexure-1.

2) Interested vendors/person who wants to participate in the tender (auction) process may Inspect the vehicle at UCO House, Alipore Kolkata / Central Staff College Salt Lake, & Executive Training Center Kolkata in between 10.00 hrs to 17.00 hrs from **21.03.2024** to **09.04.2024**. Participant has to submit sealed quotation on or before **09.04.2024 latest by 15.00** hrs to Central Security Department , 2nd Floor, UCO Bank Head Office , 10 BTM Sarani, Kolkata-01 along with two DDs-

a) DD of **Rs 250/-** in favour of UCO Bank as Tender Fee for each vehicle/ tender form which is Non-Refundable.

b) EMD (Earnest Money Deposit) –in the shape of DD of Rs.1000/- only for each Estilo.
for each Honda City the EMD is Rs.3000/-, for each Dzire the EMD is Rs.2000/- only in the shape of DD in favour of UCO Bank which is refundable. Details of vehicles is given at Annexure-.1

3) Sealed quotations will be opened on **09.04.2024** at **15.30** hrs at Central Security Department, Head Office & the highest bidder will be eligible to purchase the car.

4) The terms & Conditions of the tender are as under-

a) Anybody including staff member may participate in the tender process. Tender Notice & application form is uploaded on Bank's website also.

b) The tender should be submitted along with two DDs – DD for Tender Fee & EMD.

c) The Sealed Tenders should be super scribed 'Tender for Estilo along with vehicle No...../Honda City along with vehicle No..... / Swift Dzire along with vehicle No...../

d) The bidder should submit the tender in the given format within the prescribed time frame.

Bidders desirous for applying more than one vehicle must use one copy of format for each vehicle.

e) The bidder should submit one valid photo ID to establish his/her identity & address proof.

(Preferably- Voter Card/ AADHAR CARD/ DL)one passport size photograph .

f) After the tender process, EMD submitted by the unsuccessful bidders will be returned. At the time of delivery of vehicle, EMD of successful bidder will be returned.

g) Successful bidder should submit the amount quoted in tender within 05 working days in the form of DD in favour of UCO Bank to take the subject vehicle on as is where is basis.

h) In case the highest bidder is/are unable to take the vehicle, then Bank has every right to cancel his/her/their bid & the EMD amount will be confiscated by Bank and second highest bidder will be declared as successful bidder.

J) In case of single bid for any vehicle with a quoted value, above the market valuation (reserve price), then Bank will accept that bid & handover the vehicle, to that single bidder, as the price quoted is higher than the reserve price for that vehicle.

- Reject any or all proposals received in response to the Tender if the bidders offer less value than the average reserve price of Estilo & Honda City, Swift Dzire
- Waive or Change any formalities, irregularities, or inconsistencies in proposal.
- Extend the time for submission of proposal.
- Modify the Tender document, by an amendment that would be notified on the Bank's website.
