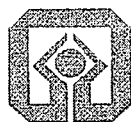




12. If, the successful bidder wants to scrap the vehicle, then he should have to submit the cut part of the **chassis number** to this office immediately.

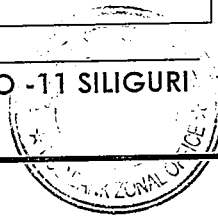

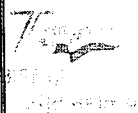

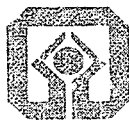
