General Instruction for guidance of applicants in respect of empanelment of contractors:

- Applications should be submitted in Bank's prescribed format only (as per annexure- I). Applications in any other form will not be considered.
- Applicants for empanelment in a trade should have experiences in execution of similar work in Banks/ Govt. Dept./Public Sector/ reputed private sector organizations in respective trades:
 - Three similar completed works costing not less than the amount equal to 40% of the estimated cost within seven years ending on 30th September 2023. Or
 - Two similar completed works costing not less than the amount equal to 50% of the estimated cost within seven years ending on 30th September 2023. Or
 - One similar completed works costing not less than the amount equal to 80% of the estimated cost within seven years ending on 30th September 2023.
- Average annual turnover of last three years
 - Category - B: Rs. 30.00 lakhs
 - Category - C: Rs. 50.00 lakhs
 - Category - D : Rs. 100.00 lakhs





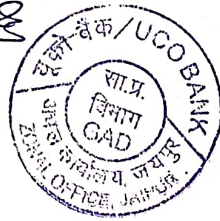
4. The applicants should have their office/establishment in Rajasthan.
5. Applicants for the trade of telephone maintenance services should be capable of liasoning with BSNL and other telephone/ mobile phone service providers for smooth functioning of telephone system.
6. The applicants for housekeeping should have sufficient numbers of personnel to manage the work efficiently.
7. Contractors applying for the trade of Electrical work should possess the valid Electrical contractor's license, issued by competent authority, in the name of the contractor or employee of the company. Photocopy of such license should be submitted with the application. (as per annexure – II)
8. Contractors / vendors applying for the trade of operation / maintenance services of air conditioning machines should have vast sound experience of operation & maintenance of all air – conditioning units.
9. The bank reserves the right to visit the establishment / workshop of applicants of any trade before finalization of empanelment.
10. The bank reserves the right to accept or reject any application without assigning any reason thereof.
11. The existing empanelled contractors of the bank need to apply afresh for empanelment against this notification.

13. Bank reserves the right to call for report from the existing clients of the applicants if the feedback from existing client is found poor/unsatisfactory the same application may be reject.

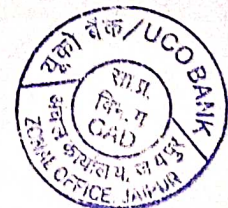

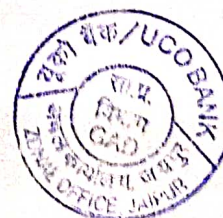

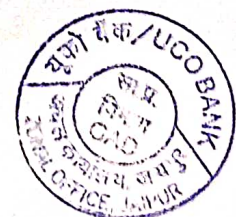
