

DC urges D'gere South voters to verify names as final electoral roll is released

DEPUTY Commissioner Gangadhara Swamy GM has requested the voters of Davanagere South Assembly constituency to verify their names in the voters list and said that any problems associated with the list should be sorted out with the BLO's.

In the wake of the upcoming elections to the Davanagere South Assembly constituency, the district administration has officially announced the

final voter list.

Speaking to the media in this regard, the DC gave comprehensive information about the steps taken for the improvement of the voter list and transparency.

There are currently a total of 2,32,564 voters in Davanagere South constituency. Out of these, 1,14,165 are male voters, 1,18,355 are female voters and 44 are other genders.

A total of 284 polling stations have been identified in the constituency. To facilitate the voting process, the district

administration has opened 67 new polling stations. And 24 polling stations have been shifted from the old location to the new location, he said.

The Deputy Commissioner clarified that adding names to the voter list is a continuous process and names can be added till the last date of filing of nominations. If a name has been omitted or if there are corrections to be made, the public can submit the requisite changes online or offline.

Voters can use the Election Commission website or mo-

bile app to check their names. The names and mobile numbers of BLOs of each polling station have already been published and the public can contact them directly, he informed.

'Pre-SIR' activity and clarification of confusions

Pre-SIR activity is currently underway to correct errors in the voter list. Under this, family mapping is being done. He added that mapping is being done by com-

paring lists of 2002 and 2025. If the name of the voter is left out, there will be an opportunity to submit requisite documents and get the changes made.

The names of deceased voters are being removed from the list based on records in hospitals and the corporation. Duplicate names of more than 57,820 voters have been found in Davanagere district and notices are being issued to the address of the concerned vot-

ers to verify them, he clarified.

Furthermore, he said that a list has been prepared of the voters who are registered in other polling stations within the constituency, other constituencies in the district, or other constituencies in the state and and/or in foreign states.

Stop propaganda

"No voter's name will be dropped suddenly from the list. Don't listen to propaganda that names will be deleted. If there is confusion, there will

be an opportunity to keep the name by providing requisite documents," he informed.

Besides this, he said that since it was not possible to provide more information after the election process was announced, the district administration has appealed to voters to be vigilant and ensure their names tally in the voters list.

Superintendent of Police Shekhar HT and Additional Deputy Commissioner Sheelwanth Shivakumar were present on this occasion.

CHARIOT FEST

Devotees shouldn't be troubled: ADC

Guru Thipperudraswamy Chariot Festival is scheduled for March 6

ADDITIONAL Deputy Commissioner B.T. Kumaraswamy has instructed officials to ensure that devotees arriving from Karnataka, Andhra Pradesh and Telangana for the annual Guru Thipperudraswamy Chariot Festival do not face any inconvenience. He issued the directions while presiding over a district-level review meeting on preparations for the festival.

The mega religious event, scheduled for March 6, is expected to draw lakhs of devotees. Kumaraswamy said several committees and sub-committees have already been constituted, and officials must discharge their duties responsibly to ensure the smooth conduct of the fair. He stressed the importance of maintaining cleanliness in the temple town, desilting drains, cleaning water tanks, and improving roads to facilitate the smooth movement of the chariot.

To prevent water contamination, he directed officials to obtain reports from the Zilla Panchayat water testing unit. Water samples must be collected from both sources and distribution points, and drinking water facilities should be inspected regularly. Gram Panchayat officials were asked to immediately repair damaged water tanks to ensure adequate water supply for cattle brought to the fair.

With rising temperatures, special emphasis has been laid on health and hygiene. Devotees must be protected from heat-related ailments, and ORS packets and essential medicines should be stocked locally. Health department officials were instructed to display awareness posters highlighting the health risks posed by extreme heat. Four first-aid centres will be established at the fair, supported by four ambulances operating round the clock. Sixty beds have been reserved at a nearby Community Health Centre, while specialist doctors, including paediatricians, will be stationed on-site. Challakere Taluk Health Officer Dr. Kashi said around 200 medical personnel will be deployed. To enhance security, officials were advised to install 50 additional CCTV cameras in parking areas, supplementing the existing 24 cameras. For crowd management and emergency response, NDRF teams will be deployed and loudspeakers installed across the fairgrounds. Police officials also recommended generator backups to ensure uninterrupted public announcements during power outages.

The ADC instructed officials to identify old and unsafe buildings along Car Street, restrict public access to such structures, and issue notices to owners. Additional Superintendent of Police Shivakumar highlighted the need for inter-departmental coordination. Following public complaints, a proposal has been submitted to ban liquor sales within a 10-km radius of the fair for two days, extending last year's 5-km restriction.
