The following terms & conditions should be complied with, while submitting the offer for the proposed premises:

- Applicant will be required : (i) to provide proof of ownership along with application and (ii) NOC for opening of bank/ATM from Competent Authority at their own cost at the time of finalization.
- The offerer must have a clear title to the property.
- Premises should preferably be located on ground floor. There could be few exceptions like premises in Malls, Shopping Centre etc. where infrastructure facilities like lifts, escalators are available.
- The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
- The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors, and Safe & Lockers Cabinet. Construction for Strong Room & ATM room as per Bank's specification should be done by the Landlord.
- The offerer will have to execute Bank's standard lease deed and bear the cost of execution and registration of Lease Deed.
- The offerer should bear all the taxes, non-conforming/misuse charges, cesses etc. if imposed, related to the premises.
- The offerer is to provide space for Generator Set, Toilets and Parking space free of cost.
- The offerer is to provide three-phase power connection with minimum power load of 15-25 KVA for the purpose.

**Facility to be provided by Landlord in the premises**

- 6 wall of R.C.C strong room to be constructed as per Bank's specification.
- White/Color washing of the premises is to be done at every 3-5 years interval. (Plastic emulsion color paint – White Aura (380051) , Solemn yellow (7882) as per color code of banks
- Separate toilets for ladies and gents to be provided by Landlord (Toilet Space should be provided by the landlord without any rental consideration i.e. on free of cost)
- 24 hours water supply to be ensure by Landlord

- e) Space to be provided for installation of V-SAT/Antenna or secondary line
- f) Space for parking of vehicles with collapsible gate with rolling shutter at main entrance
- g) Construction of ATM room with shutter as per need/specification of Bank
- h) Providing three phase connection with load capacity of 15-25KW and related work with separate electric meter on bank name.

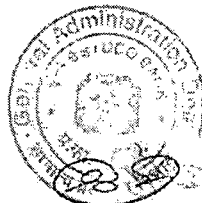
