

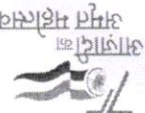

1. The auction sale will be "online e-auction" bidding through website <https://baanknet.com> on 29/12/2025 between 1:00 p.m. to 5:00 p.m. with unlimited extensions of ten minutes each.
