Offers in two separate sealed covers containing technical details and financial details on prescribed format are invited from the interested parties, who are ready to lease out (on long terms preferably for 15 years or more) their readily available premises in Paota B Road Dist- Jodhpur area of the following places with the following requisite details.

The following terms & conditions should be complied with, while submitting the offer for the proposed premises:

1. Applicant will be required: (i) to provide proof of ownership along with application and (ii) NOC for opening of Bank/ATM from Competent Authority of their own cost at the time of finalization.
2. The offerer must have a clear title to the property.
3. Premises should preferably be located on ground floor. There could be few exceptions like premises in Malls, Shopping Centre etc. where infrastructure facilities like lifts, escalators are available.
4. The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
5. The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors, Safe & Lockers Cabinet. Construction for Strong Room as per Bank's specification should be done by the Landlord.
6. The offerer will have to execute Bank's Standard lease deed and bear the cost of execution and registration of Lease Deed.
7. The offerer should bear all the taxes, non-conforming/misuse charges, cesses etc. if imposed, related to the premises.
8. The offerer is to provide space for Generator Set, Toilets and Parking space free of cost.
9. The offerer is to provide three-phase power connection with minimum power load of 15 KVA for the purpose.

The cover containing technical detail should be marked envelope no. 1 and super-scribed with Technical Bid and the cover containing financial details should be marked as envelope no. 2 & super-scribed with Financial Bid. Both these covers duly sealed should be put up in the third cover super scribed with "Offer of Premises for UCO Bank" and it should also bear the name,





address and contact number of the offer on all the three envelopes. The third cover duly sealed should be addressed to the Zonal Manager, UCO Bank.

The offer as above should be submitted in the Bank's prescribed format only which may be obtained from Zonal Office, Jodhpur or downloaded from Bank's website.

 - ❖ Do not quote rent/sale price any where in Part I of the form.

 - ❖ Each part should be kept in a separate cover and the cover containing technical details should be marked "Envelope No. 1 - Technical Bid" and the cover containing financial details should be marked "Envelope No. 2- Financial Bid".
