- Applicant will be required : (i) to provide proof of ownership along with application and (ii) NOC for opening of bank/ATM from Competent Authority at their own cost at the time of finalization.
- The offerer must have a clear title to the property.
- Premises should preferably be located on ground floor. There could be few exceptions like premises in Malls, Shopping Centre etc. where infrastructure facilities like lifts, escalators are available.
- The premises must be suitable from the security point of view and have all basic amenities such as adequate sanitary arrangements, water and electricity, natural light and ventilation.
- The premises structure should be strong enough to bear the weight of Strong Room, Strong Room Doors, Safe & Lockers Cabinet. Construction for RCC Strong Room as per Bank's specification should be done by the Landlord.
- The offerer will have to execute Bank's standard lease deed and bear the cost of execution and registration of Lease Deed on 50:50 Basis.
- The premises would be taken on lease for period of 15 years or more with option of periodic increase of rent after every 5 years.
- The offerer should bear all the taxes, non-conforming/misuse charges, cesses etc. if imposed, related to the premises.
- The offerer is to provide space for Generator Set, Toilets and Parking space free of cost.
- The offerer has to provide all kind of required NOCs including fire NOC as per the national building code, state bylaws.

- The offerer is to provide three-phase power connection in their name with minimum power load of 15 KVA for the purpose.
- Water Connection with adequate storage facility should be provided by landlord.
- EMD of Rs. 5,000/- (Five Thousand Only) in the form of Demand Draft in favour of UCO Bank, Zonal Office, Meerut to be deposited with the Technical Bid. Bid without EMD will be treated ineligible.
- EMD of unsuccessful bidder will be released (without any interest) against their request letter after completion of selection process of L-1 bidder.
- EMD of L-1 bidder will be released (without any interest) after execution of lease agreement. However, if L-1 bidder withdraws their acceptance, UCO Bank will have right to forfeit the EMD amount without making any reference.
- Conditional Tender/application may not be accepted.
