### 1. Instruction to the Tenderers:-

The tender along with Earnest Money Deposit & Tender Fee in favor of "Zonal Office, UCO Bank, Meerut" in sealed cover addressed to "Zonal Manager, Zonal Office, Meerut, Krishna Plaza, C-2/6, D-Block, Ganga Nagar, Mawana Road, Meeut (U.P.)-250001, superscripting there on "Tender for Hiring of Inverter sets" must reach the office 5.00 PM on or before dated 12/01/2018. Tenders will be opened on 11.00 AM on dated 15/01/2018. The tender received beyond the schedule time shall be summarily rejected.

#### 2. Period of Contract:-

The contract will be initially for a period of one year which can be extended further on mutual agreement subject to satisfactory performance of the agency and will also depend upon price trend for the services/ products in the market on the date of extension

## 3. Scope of work:-

- (A) The Place of performance will be branches of banks under Branch Managers
- (B) Attending to maintain the Battery backup for 6 Hrs round the clock
- (C) The Maintenance contract will include free of cost servicing & necessary repair of the installed inverters
- (D) To maintain all the power inverters in an efficient, reliable, safe and fu'ly functional condition
- (E) The Maintenance contract also include all necessary updations (if required)
- (F) In case of Three Phase Inverter sets, it will be sole responsibility of the vendor to ensure proper distribution of load on all the phases.

The Power inverters sets to be installed & maintained under this contract (Annexure-III)

## 4. Duties & Responsibilities:-

- (A) The vendor should attend to all complaints on daily besis irrespective of its nature
- (B) To use trained and appropriately skilled personnel who will be qualified to keep power inverters sets in efficient, reliable and safe generating condition (6 hrs.) in all the working days
- (C) To regularly examine, status of battery back up and carry out planned maintenance in a systematic and controlled manner
- (D) To maintain highest order of integrity, moral and social responsibility and decorum of the bank
- (E) The technician also liable to work on all holidays and Saturday/ Sunday (if services are required) and no additional amount will be paid

## 5. Eligibility Criteria:-

(A) The Agency applying should possess Income Tax PAN No. & GST. The agency should have minimum experience of 03 yrs in providing such type of services in central Govt./ state govt./ public sector undertaking/ autonomous bodies

#### 6. Evaluation of Bids:-

- (A) "Sealed Cover- I, Technical bid- Hiring of Power Inverters" It shall contains the EMD, tender fee & documents (a-g) and
- (B) "Sealed Cover- II, Financial bid- Hiring of Power Inverter". It shall contains only rates/price bid, the page titled "Price Bid" of the tender form with rates duly filled and with signature and seal on the page
- (C) Both the two envelopes identified by cover-I and Cover –II put inside the main envelope duly sealed "Cover- Main, Tender for Hiring of Power Inverters for L/F load of branches in the Zone: Meerut" due on 12/01/2018".
- (D) Tenders are to be addressed to the Zonal Manager, UCO Bank, Zonal Office, Krishna Plaza, C-2/6, D-Block, Ganga Nagar, Mawana Road, Meerut-250001 (U.P.) must submit/ reach the office by 5.00 PM on or before 12/01/2018.
- (E) The bid must satisfy all the terms and conditions mentioned in this documents and must be accompanied by all the requisite documents
- (F) Filling of all the columns in Techno-Commercial Bid and Price bid is compulsory
- (G) One representative of the tenderer can be present to witness the tender opening

## 7. Earnest Money Deposit & Tender Fee:-

The tenders should be accompanied by **EMD** of Rs 10,000/- in the form of A/C payee D.D./
F.D.R/ unconditional Bank Guarantee & **Tender fee** of Rs. 500/- (non refundable) In the form of A/C payee D.D. (separate) non refundable from any of the nationalized/ schedule banks in an acceptable form drawn in favor of UCO Bank payable at Meerut without which the tender will not be considered. The EMD will be returned to all the unsuccessful tenders after finalizing of the contract

## 8. Other Terms & Condition

- (A) The above work will be completed in phased manner. Firstly, we will allow to install required capacity's invertors in five branches. After two months, Zonal Office will review the performance of installed inverter, if works/ service found satisfactory then Bank will allow to install inverters in other branches in next phase as per Bank's requirements.
- (B) The Zonal Office, Meerut has the right of accepting or rejecting any or all the tenders without specifying any reason (s) thereof. The UCO bank is under no obligation to accept the lowest tender.
- (C) There is no obligation on the part of the Zonal Office, Meerut to inform the unsuccessful tenderer of the outcome of the tender process and reasons for rejection of tender.
- (D) Payment of contractual value, in appropriate proportion, shall be released every quarter (3 Months) based on the performance and service of the agency.
- (E) It shall be mandatory on firm to conduct routine checks to maintain the Inverter sets and batteries in perfect working condition and to submit the routine check reports on quarterly basis to the Zonal Office, ZO Meerut.

- (F) The rates offered in the tender will not be enhanced during the period of contract. The rates finally approved/ accepted by the competent authority of UCO Bank shall be valid for the whole of the contract tenure and no upward revision will be allowed under any circumstances whatsoever.
- (G) Under no circumstances, shall the successful agency appoint any sub-contractors or sub-lease the contract. If it is found the contractor has violated these conditions the contract will be terminated forthwith without any notice, by the authority who has approved the award of the contract.
- (H) The Zonal Office, Meerut, UCO bank can terminate the contract, at any time without assigning any reason. In this respect, the decision of Zonal Manager Meerut will be final and binding on the contract.
- (1) The bills submitted duly signed by the Branch Managers submitted to this office for effecting payment
- (J) The arrangement of tools required for repair/ servicing of the power inverter will be responsibility of the bidder and the parts including battery to be changed for maintenance/ proper working should be original. The UCO Bank will not provide in any condition.
- (K) The intended bidders have to attach the price list of parts which are required to be changed for maintenance and proper working of power inverters.
- (L) It will be duty of the agency/ inverter vendor to have the credentials of the service technicians verified and certified.
- (M) The agency will ensure that qualified and good character technician minimum ITI or diploma holder from recognized institute or board are deputed for performance of maintenance work. In case any change in technician the details must be informed to UCO Bank authorized authority in advance.
- (N) Response time, removal of defects must be under mentioned in log book, duly maintained and signed by B.M. failing which penalty mentioned there against shall be levied against the agency (s)
- (O) The job carried out shall be the satisfaction of Zonal Office, Meerut, UCO Bank.
- (P) The Zonal Office, Meerut of UCO Bank reserve the right to review the performance wherever so desired. The Zonal Office, reserves the right to increase or decrease the quantity of branches/ power inverters or alter any terms and conditions of the tender document (s) at the time of execution of AMC/ Hiring/ rental services.
- (Q) The agency shall strictly comply with the provision of the safety code including obtaining necessary insurance cover/ policy to protect Bank's interest on account of loss to any person (s) and or property arising due to faulty installation etc. on agency's part.

- Fluorescent light to be replaced by LED lightning to improved the energy efficient
- However the technician should be maintained day to day status duly signed by the Branch Manager
- · No looping/ overlapping of wires allowed

#### ANNEXURE-II

#### INVERTER

#### Part - 1: Scope of Maintenance

- 1. Ensuring that Inverter is always kept in clean, healthy working condition.
- 2. Attending day to day routine complaints in a prompt and satisfactory manner.
- 3. Ensuring that no breakdown in power supply takes place and in case it happens, to take all required steps including contacting supply co. for earliest restoration.
- Ensuring that there is output power and charging current at same type.
- Ensuring that there is no wastage of electrical energy. Details of steps to be taken in this regard to be worked out inconsultation with the Engineer- in- charge.
- 6. carrying out minor additions and alterations ordered by Manager/ Branch In-charge
- 7. Carrying out various maintenance routines and tests as stated in Part-III
- 8. Maintaining registers for complaints and test results.

#### Part - II: Tasks to be performed within first 30 days.

Following items should be carried out within first 30 days.

- 1. Measurement of the resistance of Earth Stations of the System and checking of the continuity of earth conductor. Results to be
- 2. Inspection/ checks of Inverter shall be brought to the requirement as following:
- (a) Any loose / improper connection (no strand cutting for making connection to be allowed).
- (b) Improper rating of switches/ fuse
- (c) Cleanliness.
- (d) No voltage variation in output, beyond ± 1% under specified input supply conditions.
- (f) No Frequency variation beyond 50 Hz  $\pm$  0.5Hz
- (g) All indicators are in healthy condition
- (h) All protection circuits are in working condition.
- (i) THD shall be 5 % up to 5 KVA and 3% beyond 5 KVA (Input harmonics less than 10%)
- (j) Efficiency shall be better than 90%
- (k) Inverter shall withstand overload as per manufacturer's specifications.
- (1) All metering devices are in working condition.
- General inspection of Inverter system to identify shortcoming. Also any other relevant aspect which may come in the way of proper maintenance should be recorded in register and also brought to the notice of Manger
- 4. Insulation test and leakage current high voltage as per IS: 616/86

#### Part - III: Maintenance schedule to be followed.

Daily checks (applicable for buildings where operation is part of scope else to be carried out at the time of routine visit)

- 1. Check
- (i) Any abnormal heating.
- (ii) All protection circuits and metering devices are in healthy condition.
- (iii) Any breakage / damage or loose connections in the equipment installed.
- (iv) Any inflammable material like oil, broken furniture, packing etc. are stored tear the installation. If fire hazardous material stored, it has to be removed immediately. If required, contact Manager GAD/ Security for suitable action.
- (v) All indicators are in healthy condition.
- 2. Other Checks
- 1. Testing of earthing system for earth resistance and continuity: Six Monthly or initial testing.
- 2. Voltage/ Frequency variation/ THD test of System: Every Three Months after initial testing including submit the service report regarding the healthiness of system, back-up time, Specific gravity readings of battery, Voltage, VA etc.
- 3. Insulation test of Inverter System: Every Year of initial testing.
- 4. Efficiency test: Every Year of initial testing.
- 5. Or otherwise Periodical maintenance shall be done as per manufacturer's recommendation, whichever is earlier.
- 6. Healthiness of batteries inclusive of cleaning and providing general consumable items (except replacement of batteries)

### Part - IV: Materials

 All the materials required for carrying out maintenance shall be arranged by the agency at his own cost including replacement of batteries
