The bidder has to provide Bank with the UTR no. generated after the NEFT (hard copy of the receipt generated should be submitted along with the bid documents), failing which the bid of the concerned bidder will be rejected.	As per the NSIC CIN No. U74140DL1955GOI002481, there is clause that "Issue of the Tender Sets free of cost". It is requested that please allow NSIC bidders to avail this exemption.	The clause stands modified as under:- NSIC registered bidders are exempted from issuance of tender cost on submission of NSIC certificate.
